



DIRECTIVE

regarding specific security measures in the Apartments of the Museum of the Second World War in Gdańsk in connection with the COVID-19 epidemic

§ 1.

General provisions.

1. In connection with the COVID-19 epidemic specific security measures are applied in the Apartments of the Museum of the Second World War in Gdańsk, hereinafter referred to as "Apartments".
2. This directive applies to everybody who enters the Apartments' building, especially to the Apartments' staff, co-workers and hotel guests.
3. The receptionist is responsible for monitoring and regularly refilling the hand sanitizer dispensers located in the Apartments' building.

§ 2.

Safety regulations regarding the COVID-19 epidemic.

1. The Lessor has the right to take the temperature of the guests staying at the Apartments of the Museum of the Second World War in Gdańsk.
2. The Lessee is obliged to sign a declaration about his health status at check in.
3. If the Lessee refuses to sign the declaration or have his temperature taken, the Lessor has the right to refuse check-in and is not obliged to refund the payment made by the Lessee.
4. The Lessee is always obliged to sanitize his hands directly after entering the facility and before using the common kitchen. The hand sanitizer dispensers are located near the entrance in front of the reception desk and next to the kitchen door.
5. It is obligatory to wear face masks when entering common areas, in accordance with the guidelines of the Ministry of Health.
6. No more than 2 people can stand next to the reception desk at the same time.
7. No more than 4 guests can stay in one apartment and no more than 2 guests in one guest room.
8. It is strictly forbidden for people not registered at the Apartments to stay in the facility. The prohibition does not apply to the Lessor's employees and those who received an appropriate permission from the Lessor.
9. Common areas, like the kitchen or the children's playing room can be temporarily unavailable for guests.
10. In case the guest experiences alarming health symptoms during his stay, he is obliged to immediately inform about it the Crisis Team Manager at the Museum of the Second World War in Gdańsk – Jakub Zambrzycki, phone number +48 695-860-108.
11. The Lessor has the right to stop receiving Guests in case of suspected infection in the Apartment's building. This suspension can be the result of a decision made by the sanitary-epidemiological services and will be seen as force majeure. As such, it is not considered the Lessor's fault and excludes



his responsibility for any possible damage experienced by the Lessee. In such case the Lessor will refund the advance or the payment for the remaining period of stay.

§ 3.

Final provisions.

1. Any matters not provided for in this directive shall be governed by the Regulations of the Apartments of the Museum of the Second World War in Gdańsk.
2. Failure to observe the above regulations will be seen as exposing to risk the safety of other people and can result in the guest not being allowed to continue his stay in the Apartments.
3. The directive enters into force on the day of its signature.
