

REGULATIONS

UNDERGROUND PARKING AT THE MUSEUM OF THE SECOND WORLD WAR IN GDAŃSK

1. The car park is an integral part of the Museum of the Second World War in Gdańsk and is a paid, unguarded car park.
2. The Museum of the Second World War is not responsible for the loss or damage to vehicles in the car park, and is not responsible for any items left in the vehicles.
3. The car park is open daily from 10:00 am – 8:00 pm with the exception of parking of vehicles belonging to hotel guests (hotel guest parking is available 24 hours a day) and for restaurant guests (parking available until 11.30 pm).
4. It is strictly forbidden for vehicles carrying hazardous materials, especially flammable, corrosive and explosive materials, including those equipped with a gas installation, to enter the car park .
5. The provisions of the Road Traffic Act (consolidated text, The Law Journal, 2021, item 450) apply to the car park including a maximum speed for all vehicles of 10 kph for all access roads and internal roads.
6. While parking, the driver is obliged to pay special attention to any neighboring vehicles.
7. It is forbidden to park the vehicle:
 - a) on access roads and roads joining traffic,
 - b) in separated and marked off places, except for authorized vehicles,
 - c) in places where parking a car may pose a threat to the movement of vehicles, people or property.
8. In the car park, it is forbidden to repair, wash, vacuum the car or replace car coolants, fuel or oil as well as causing contamination to the car park.
9. Payments for parking:
 - a) museum visitors and customers:

- the first hour is free,
 - each subsequent hour commenced – 5 zloty,
- b) for hotel guests - parking in the car park is free,
- c) for authorized museum employees - parking during working hours is free
- d) for museum co-operators, employees of catering establishments, the museum shop, hotel service staff , etc. - parking is payable with the exception of authorized persons and with the exception of deliveries,
10. Other fees:
- a) Fee for a lost or uncollected parking ticket – 200 zloty;
 - b) Fee for incorrect use of the car park - e.g. parking in two places, taking a place for disabled people without authorization – 100 zloty;
 - c) Fee for leaving the vehicle after closing - 150 zloty / day;
 - d) Fee for removing the vehicle from the parking lot – 400 zloty;
11. Obtaining a ticket:
- a) Before entering the car park, the user should collect a ticket from the parking ticket machine;
 - b) The parking fee is payable at the payment machine in the underground car park;
 - c) After paying the parking fee, the vehicle should leave the car park within 15 minutes, otherwise the user will be charged a fee for each additional hour of parking.
12. The vehicle user is responsible for any damage caused to the Museum and third parties in the car park.
13. Employees of the Museum are authorized to enforce all legal rights in the car park.
14. The museum is not responsible for the theft or destruction of cars left in the parking lot.
15. These Regulations are valid from 01/01/2022.
